Objectives

The course objective is to teach students to become competent users of accounting data and to fully integrate their understanding of basic accounting transactions, and related profits, cost behaviour, relevant costs and control systems into their analysis of business problems. Regardless of career objectives, all students will have to deal with some form of accounting information in their day-to-day activities. The task of this course is to ensure a thorough understanding of the nature and behaviour of costs so that this type of information can be positively incorporated into the decision-making framework. Knowledge of a spreadsheet program is beneficial.

<u>Please note</u>: Do not expect that the online version of this course will be <u>EASIER</u> than the in-class version of MOS 3372; you are simply subscribing to a different manner of delivery of the same topics. You will need to self-assess your ability to keep on track with reading assignments and problems; <u>learning several chapters all at once in advance of an exam is definitely not recommended</u>. In some ways, going to a physical classroom increases the chance that you will learn concepts by "osmosis"; the same outcome will not occur with this format. You are responsible for your own learning, and I, as the instructor, will facilitate your learning. I will provide you with lecture notes to supplement the assigned readings, presented to you in an understandable, user-friendly manner that incorporates my humour, and the use of examples to illustrate the concepts.

Prerequisites: Business 257 or equivalent financial accounting course – refer to the Western Academic Calendar for further details.

Participation

- Frequent explanations of difficult points or concepts to other online students
- Positive direction demonstrated

B- Good Contribution

- Consistent contribution to online discussions
- Contributions indicating preparation for class by pre reading assigned material
- Often demonstrates capability to explain difficult points or concepts to other online students
- Positive direction demonstrated

C- Fair Contribution

- Contributed to online discussions.
- Contributions indicated preparation for sessions
- Positive direction demonstrated

D- Poor Contribution

- Infrequent contribution to class discussions
- Contributions give little indication of preparation for class
- Did not assist in developing positive atmosphere within discussion forum.

E-Unsatisfactory Contribution

- Rarely contributed to class discussions
- Gave no indication of preparation for class
- Actively inhibited or impeded the course of class discussion
