## 1. Course Information:

### 1.1 Class Location and Time:

### **1.2** Course Description:

This course provides overview of issues in financial management and corporate finance. Students will learn how financial managers make investment, financing and other decisions and the tools they use to make such decisions. Topics covered include time value of money, risk, valuation, capital structure, dividend policy and other selected issues.

Antirequisite(s): at Main campus: Financial Modelling 2555A/B, and MOS 3310A/B. Antirequisite(s) at Huron campus: Financial Modelling 2555A/B, MOS 3310A/B, the former Actuarial Science 2555A/B.

Prerequisite(s): Enrolment in BMOS, Music Administrative Studies (MAS), or Honours Specialization in Urban Development.

# 3. Course Objectives and Format

The DAN Department of Management and Organizational Studies as a whole draws upon an evidence-based management approach. Evidence-based management is the systematic process of gathering

evidence from multiple sources, critically appraising the evidence, and using that evidence in making and evaluating management decisions to improve organizational performance.

# 3.1 Course objectives

- The objective of this course is to introduce the participant to the fundamentals of corporate finance. Every decision that a corporation makes has financial implications, and any decision which affects the finances of a corporation is a corporate finance decision. The participant will learn how these business decisions are tied together by one powerful concept, the Valuation Principle.
- Whether you plan to major in finance or simply take this one course, you will find the fundamental financial knowledge gained to be essential in your personal and business lives.

#### 3.2 Course format

The course is scheduled as a series of 3-hour in-person lectures.

In some weeks, aspects of this course MAY be conducted in a hybrid format with some asynchronous course material delivery, and remaining time spent in-person with synchronous discussion/tutorials. Synchronous discussion will normally be conducted in-person during regularly scheduled class time.

The course format is subject to change based on Covid-19 protocols or restrictions. Therefore, aspects of this course MAY be conducted in a hybrid format with asynchronous course material, and weekly synchronous discussion/tutorials. Any such tutorial sessions will be conducted via Zoom during regularly scheduled class time and will be intended to be interactive.

Any remote learning sessions for this course MAY be recorded from time to time. The data captured during these recordings may include your image, voice recordings, chat logs and personal identifiers (name displayed on the screen). The recordings will be used for educational purposes related to this course, including evaluations. The recordings may be disclosed to other individuals under special circumstances. Please contact the instructor if you have any concerns related to session recordings.

<u>Participants in this course are not permitted to record the sessions, except where the participant has the prior written permission of the instructor.</u>

# 4. Learning Outcomes

Upon completion of the course, successful students should be able to:

- Demonstrate basic knowledge of financial markets and institutions and explain how firms obtain funds in the markets and at what cost
- Calculate the time value of money and apply the concepts to the valuation of financial securities such as bonds and stocks
- Distinguish among various types of risks and apply the Capital Asset Pricing Model to calculate returns, given appropriate risk measures
- Calculate the cost of capital and solve capital budgeting problems
- Explain how a firm might set its dividend policies
- Analyze a firm's performance to determine its strengths and weaknesses, and be able to use financial analysis to improve performance
- Explain various strategies for managing a firm's short-term assets and liabilities

## 5. Evaluation

IMPORTANT: <u>See Essential Learning Requirements (below in Section 5), regarding minimum requirements to earn a passing grade, and minimum requirements to earn a grade of 60% in this course.</u>

Six problem sets will be assigned for independent completion via OWL. Question formats may include multiple choice, true/false, numeric answer, fill in the blank, or short answer. Problem sets will typically be assigned on a Friday and will be due for submission on the following Monday at 11:55pm (giving a three-day window for completion). Once started, most problem sets will have a time-limit of 3-4 hours and will automatically be submitted once the time limit has been reached (though students may submit sooner). In addition, students will be required to complete a Data Analytics case study, which will be completed in groups using either MS Excel or Power BI (TBD). More information will be provided on the course OWL site.

The midterm exam is expected to be delivered in-person, scheduled for **2 hours, and will consist of approximately 40 multiple choice questions.** [This format and duration may change if Covid-19 protocols require that the exam be delivered online]

The final exam is expected to be scheduled for **3 hours and will consist of approximately 60 multiple choice questions.** Question formats will be similar to the midterm exam. [This format and duration may change if Covid-19 protocols require that the exam be delivered online]

Only non-programmable calculators (including non-programmable financial calculators) will be allowed into the exams. Graphing calculators are not permitted! Students using a programmable and/or graphing calculator during an exam will be assigned a minimum exam grade penalty of 25%. If you are unsure about whether your calculator is permitted, please ask your professor to check your calculator BEFORE the exam day.

Electronic devices of <u>any</u> kind (including pagers, cell phones, smart watches, and programmable calculators) are NOT permitted at exams. If students have cell phones or other electronic devices, these devices MUST be turned off and stored away from the student during the exam. Devices many not be kept on the exam desk or on students' person (in pockets) during the exam, even if turned off. Contravention of this policy will be treated as an academic offense, and will result in an automatic grade of 0 (zero) on the exam.

Exams may be scored using a program that examines the answer sheets for unusual coincidences in the pattern of answers given which may be indicative, and used as supporting evidence, of cheating. Suspected cheating on any exam will result in a grade of 0, and will initiate an investigation of academic offence.

This course has other exam guidelines and expectations which will be clearly outlined in documents on the course website. Students are expected to understand and adhere to these guidelines to avoid grade penalties.

Students are responsible for all material covered during lectures or tutorials, as well as any assigned videos or readings from the text or elsewhere on the course website.

Students are **REQUIRED TO COMPLETE ALL COMPONENTS** of this course in order to justify earning a passing grade. There are no exceptions to this. Extra assignments to improve grades **will NOT** be allowed.

The instructor reserves the right to adjust all grade components and final grades, up or down, by standardizing to a pre-determined common mean range. As such, students' grades will be partially determined based on their results relative the class average. Standardization of grades is designed to control for variations in assessment difficulty across different delivery methods, and to ensure fairness across sections.

Exams will not be returned to students but may be reviewed by contacting your instructor.

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make <u>one</u> Academic Consideration request **without supporting documentation** in this course. However, the following assessments are excluded from this, and therefore always require formal supporting documentation:

- Examinations scheduled during official examination periods (Defined by policy)
- Midterm Exam (Designated by the instructor as the <u>one</u> assessment that always requires documentation when requesting Academic Consideration)

When a student <u>mistakenly</u> submits their <u>one</u> allowed Academic Consideration request **without supporting documentation** for the assessments listed above or those in the **Coursework with Assessment Flexibility** section below, <u>the request cannot be recalled and reapplied</u>. This privilege is forfeited.

#### **Evaluation Scheme for Missed Assessments**

Midterm Exam: There is no make-up midterm exam in this course. If a student misses the regularly scheduled midterm exam for any reason, and for which adequate documentation is received by the instructor (this documentation must be supplied by the Academic Counseling office), then the student will receive a modified and lengthened final exam which will be re-weighted to 75% of the course grade weight. The modified exam will be scheduled for four (4) hours and may have a slightly modified format than the regularly scheduled final exam, including the possibility of written responses and calculations, in addition to multiple choice questions. The format and location of

the modified final exam will be specified to eligible students at least 10 days prior to the date of the final exam.

**Final Exam**: If a student misses the regularly scheduled <u>final exam</u> for any reason, and for which adequate documentation is received by the instructor (this documentation must be supplied by the Academic Counseling office), then the student will be permitted to write a Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under <u>Special</u> Examinations), especially for those who miss multiple final exams within one examination period..

The date and time of the make-up examination will be determined by the department and the University Special Examination dates as outlined in the Academic Handbook: <a href="https://www.uwo.ca/univsec/pdf/academic policies/exam/definitions.pdf">https://www.uwo.ca/univsec/pdf/academic policies/exam/definitions.pdf</a>. The make-up (Special Examination) exam is expected to be held at 9:00am or 1pm on May 9, 2025, in SSC 4317. This time and location may be modified if required by the Department due to space limitations or conflicts.

The format of the Special final exam (make-up) may be different than the format of the regularly scheduled exam, but will contain the same breadth and depth of coverage.

If a student is unable to meet the scheduled make-up, then the student is responsible for obtaining new accommodations from Academic Counselling. It approved by the Dean's office, such student may be given an opportunity to write a deferred make-up final exam during the regular final exam period the next time the course is offered in-person. This is expected to be in December 2025.

## **Essential Learning Requirements**

Even when Academic Considerations are granted for missed coursework, the following provisions are deemed essential to earn certain grades, including a passing grade, in this course:

- 1) Students must achieve a minimum grade of 50% on the final exam in order to achieve a passing course grade (50% or higher) in the course. Students who do not achieve a final exam grade of at least 50% will be assigned a final course grade of 45%, or their actual calculated course grade, whichever is LOWER.
- 2) Students must achieve a grade of at least 55% on at least one of the exam components (midterm or final exam) of the course in order to achieve a final course grade of 60% or higher. Students who do not score at least 55% on at least one of the course exam components will be assigned a final course grade of 55%, or their actual calculated course grade, whichever is LOWER.
- 3) Students must complete the Case Study Assignment in order to achieve a passing course grade (50% or higher) in the course. This assignment is designed to be completed in groups. Any student who does not participate in completing the assignment with their group prior to the final deadline (see Assessment Flexibility below), will earn a grade of 0 on the assignment. Such student will be given an opportunity to complete an independent assignment, prior to final course grade submission, to replace the missed group assignment, however, they will not receive any course grade credit for completing the assignment. Any student who does not submit either the regular Case Study Assignment, or the replacement assignment, prior to the respective established final deadlines will be assigned a final course grade of 45%, or their actual calculated course grade, whichever is LOWER.

#### **Coursework with Assessment Flexibility**

By policy, instructors may deny Academic Consideration requests for the following assessments with universal accommodation and built-in flexibility:

#### **Flexible Completion**

**Problem Sets:** Universal accommodation is built-in to the grading policy for Problem Sets by automatic dropping of the lowest problem set grade (only the top 5 out of 6 problem set marks will count toward the student's final grade). Please refer to the course expectation documents for further information. **In general, there are no extensions, make-ups, or re-writes for any missed problem sets.** Students will receive this universal accommodation, irrespective of whether they seek academic accommodation (with or without documentation). Students who face extraordinary circumstances, which require multiple problem sets to be missed, should seek advice and/or accommodation through the Academic Counselling office of their respective faculty. In such rare instances, grade re-weighting may be available on a case-by-case basis.

**Group Case-Study Assignment:** The case-study assignment is expected to be submitted as a group by the assigned deadline. Universal accommodation is automatically provided to all groups to address situations where a group is unable to submit, for any reason, by the official assigned due date. In such instances, students <u>do not</u> need to request Academic Consideration as they will be permitted to submit their assignment up to 79 hours past the deadline without a late penalty. Any submissions received after 79 hours past the deadline will receive a grade of zero. Please note that all students are required to participate in the submission of the case study assignment in order to achieve a passing grade in the course (see Essential Learning Requirements above).

Grades <u>will not be adjusted</u> on the basis of need. It is important to monitor your performance in the course. Remember: *You* are responsible for your grades in this course.

The DAN Department has a grade policy which states that for courses in the 2000 range, the class average must fall between 65% and 72% for all sections of a course taught by the same instructor. In very exceptional circumstances only, class averages outside this range may be approved by the Undergraduate Chair or Chair. Class averages are not grounds for appeal.

# 14. University Policy on Cheating and Academic Misconduct

Students are responsible for understanding the nature of and avoiding the occurrence of plagiarism and other academic offenses. Students are urged to read the section on Scholastic Offenses in the <u>Academic Calendar</u>.

Note that such offenses include plagiarism, cheating on an examination, submitting false or fraudulent assignments or credentials, impersonating a candidate, or submitting for credit in any course without the knowledge and approval of the instructor to whom it is submitted, any academic work for which credit has previously been obtained or is being sought in another course in the University or elsewhere. If you are in doubt about whether what you are doing is inappropriate, consult your instructor. A claim that "you didn't know it was wrong" will not be accepted as an excuse.

Within this course, students are permitted to use AI tools exclusively for information gathering and preliminary research purposes. These tools are intended to enhance the learning experience by providing access to diverse information sources. However, it is essential that students critically evaluate the obtained information, exercise independent thinking, and engage in original research to synthesize and develop their own ideas, arguments and perspectives. The use of AI tools can serve as a starting point for exploring a topic, with students expected to uphold academic integrity by appropriately attributing all sources of information and avoiding plagiarism. Essays, written assignments and/or lab reports should reflect the student's own thoughts and independent written work. Students should also generate their own figures (e.g., graphs, diagrams) rather than using AI generated ones. By adhering to these guidelines, students contribute to a responsible and effective learning environment that promotes critical thinking, independent inquiry and all them to produce original written contributions. The same principles also apply to the use of translation software to support the writing the essays and other written assessments. When used, any such AI or translation tool should be used ethically and responsibly, and students must cite or credit the tools used in line with the expectation to use Al as a tool to learn, not only to produce content. Al tools are never permitted for use to answer questions on problem set assignments.

Cheating on exams will not be tolerated; students are referred to the university policy on scholastic offenses. Looking at the test of another student, allowing another student to view your exam, or obtaining information about a test in advance are all examples of cheating.

Students found cheating will receive a zero (0%) on that exam. A number of safeguards will be employed to discourage cheating. For example, examination supervisors (proctors) of the tests may ask students to move to another seat during the exam, cover their paper, avert their eyes from other students' papers, remove baseball caps, etc. This is not meant as a personal affront nor as an accusation of cheating, rather as vigilant attempts at proctoring.

The penalties for a student guilty of a scholastic offense include refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

# 15. Procedures For Appealing Academic Evaluations

- 1. In the first instance, all appeals of a grade must be made to the course instructor (informal consultation).
- 2. If the student is not satisfied with the decision of the course instructor, a written appeal must be sent to the Undergraduate Chair of the Department of Management and Organizational Studies.
- 3. If the response of the Undergraduate Chair is considered unsatisfactory to the student, they may then appeal to the Dean of the Faculty in which the course of program was taken.
- 4. Only after receiving a final decision from the Dean may a student appeal to the Senate Review Board Academic. A Guide to Appeals is available from the <u>Office of the Ombudsperson</u>.
