## **1.2** Course Description:

The fundamentals of aviation law emphasizing factors guiding operational decision-making by aviation managers and professional pilots. Topics will include the regulation of aviation traffic and commercial and public airports, personnel licensing and training, general operating and flight rules, air transport regulators and associations.

Antirequisite(s): None

Prerequisite(s): Enrollment in 3rd or 4th year of the Commercial Aviation Management module of BMOS or Geography and Commercial Aviation Management module.

# 3. Course Objectives and Format

The DAN Department of Management and Organizational Studies as a whole draws upon an evidence-based management approach. Evidence-based management is the systematic process of gathering evidence from multiple sources, critically appraising the evidence, and using that evidence in making and evaluating management decisions to improve organizational performance.

## 3.1 Course objectives

The purpose of this course is to introduce students to the fundamentals of Canadian law in general, and aviation law in particular.

# 4. Learning Outcomes

- Describe the basic sources of law (treaty, constitutional, statutory, regulatory, judge-made) applicable to aviation.
- Understand substantive and procedural aspects of aviation law, and the role of legal counsel.
- Demonstrate how abstract legal principles are applied in concrete factual settings.
- Evaluate concrete factual settings and present arguments for particular legal outcomes.
- Respect, discuss and compare competing points of view.
- Persuade others of a well-reasoned legal stance or action.
- Demonstrate effective critical thinking skills.

## 5. Evaluation

Class Participation: 10% Midterm Exam #1: 30% Midterm Exam #2: 30%

\*\*Academic consideration for this exam requires supporting documentation

Final Exam: 30%

#### **Class Participation**

A 10% grade will be awarded on the basis of classroom attendance: 1% is earned for each class (except the midterm exam) attended in full up to a maximum of 10%. In addition, students will be expected to discuss assigned readings and cases.

Students are expected to have completed all assigned readings in a timely fashion and be prepared to discuss such material in class. Attendance will be taken at the beginning of each class, and students <u>must be present for the entire class</u> to receive an attendance grade for that class. (Students arriving late or leaving early will not receive an attendance grade.)

#### **Exams**

Exams are multiple and short answer in format. Each exam, in total, will be scheduled for 2 hours and is a closed book examination.

The first midterm exam is scheduled during Class 6 on <u>Thursday</u>, <u>February 12</u>, 6:30 pm – 8:30 pm. It will cover assigned readings, lectures and class discussion from class 1 through class 4 inclusive.

The second midterm exam is scheduled during Class 10 on Thursday, March 19, 6:30 pm – 8:30 pm. It will cover assigned readings, lectures and class discussion from class 5 through class 8 inclusive. Note: \*\*Academic consideration for this exam requires supporting documentation.

The final exam (date to be determined by the Registrar) will not be cumulative, i.e., it will only cover assigned readings, lectures, assignments and class discussion from class 9 through to 12 inclusive.

Dictionaries are NOT allowed into the examinations. Electronic devices of <u>any</u> kind (including cell phones, smart watches and calculators) are NOT permitted at exams.

Students are responsible for material covered in the lectures as well as the assigned chapters/sections in the text. Exams will not be returned to students but may be reviewed by contacting your instructor.

Students are **REQUIRED TO COMPLETE ALL COMPONENTS** of this course. There are no exceptions to this. Extra assignments to improve grades **will NOT** be allowed.

#### 5.1 General information about missed coursework

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make <u>one</u> Academic Consideration request **without supporting documentation** in this course. However, the following assessments are excluded from this, and therefore always require formal supporting documentation:

- Examinations scheduled during official examination periods (Defined by policy)
- Midterm #2 (Designated by the instructor as the <u>one</u> assessment that always requires documentation when requesting Academic Consideration)

When a student <u>mistakenly</u> submits their <u>one</u> allowed Academic Consideration request **without supporting documentation** for the assessments listed above or those in the **Coursework with Assessment Flexibility** section below, <u>the request cannot be recalled and reapplied</u>. This privilege is forfeited.

#### **5.2** Evaluation Scheme for Missed Assessments

Aside from the <u>one</u> exception noted above (that is not excluded), all academic consideration will require supporting documentation. If academic consideration is granted:

- In the case of attendance, attendance will be recorded.
- In the case of assignments, a grade equivalent to the average grade of the other assignments will be given.

• In the case of Midterm Exam 1, students will be given the opportunity to re-write the exam at a specified date to be scheduled by the instructor.

When a student misses the Final Exam and their Academic Consideration has been granted, they will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under <u>Special Examinations</u>), especially for those who miss multiple final exams within one examination period.

The date and time of the make-up examination will be determined by the department and the University Special Examination dates as outlined in the Academic Handbook: https://www.uwo.ca/univsec/pdf/academic policies/exam/definitions.pdf.

The make-up exam for the missed final exam will be held **after the first Thursday in January following the beginning of classes** 

The date and time of the make-up examination will be set by the instructor, who will communicate the date to the student.

If a student is unable to meet the scheduled make-up, then the student is responsible for obtaining new accommodation from Academic Counselling, and seeking a new make-up date with the instructor within a reasonable time frame.

Grades <u>will not be adjusted</u> on the basis of need. It is important to monitor your performance in the course. Remember: *You* are responsible for your grades in this course.

The DAN Department has a grade policy which states that for courses in the 3000-4000 range, the class average must fall between 70% and 77% for all sections of a course taught by the same instructor. In very exceptional circumstances only, class averages outside this range may be approved by the Undergraduate Chair or Chair. Class averages are not grounds for appeal.

## 10. Attendance

It is expected that students will attend all classes. The instructor does not provide access to lecture notes. Students are encouraged to obtain missed lecture notes from a fellow student.

#### **10.1** Short Absences.

If you miss a class due to minor illness or other problems, check your course outline for information regarding attendance requirements and make sure you are not missing a test or exam. Cover any readings and arrange to borrow the missed lectures notes from a classmate.

#### 10.2 Extended Absences.

If you are absent more than approximately two weeks or if you get too far behind to catch up, you should consider reducing your workload by dropping one or more courses. The <u>Academic Counsellors</u> can help you to consider the alternatives. At your request, they can also keep your instructors informed about your difficulties.

#### 11. Grade Fairness

Fairness requires that all students be treated equally and be evaluated using the criteria set out in this course outline. The evaluation criteria are based on actual achievement and not on how hard a student has tried.

Claims by students of an excellent academic history, good attendance record, need to obtain or maintain a scholarship, desire to be admitted to Ivey or graduate school, or other personal issues, cannot be used to justify a higher grade in the course or a reweighting of course components. There is no extra work or assignments available for extra credit or to "make up" for a course component that was missed or performed poorly.

You, the student, are responsible for the grades earned.

# 12. Posting of Grades

Midterm exam grades will be posted on OWL once the grades are available. Final exam grades and final course grades are not posted on OWL and are available once they have been posted by the Registrar under "Academic Summary" at the <u>Student Centre</u> website.

Any work submitted must be the work of the student in its entirety unless otherwise disclosed. When used, any such AI or translation tool should be used ethically and responsibly, and students must cite or credit the tools used in line with the expectation to use AI as a tool to learn, not only to produce content.

Cheating on exams will not be tolerated; students are referred to the university policy on scholastic offenses. Looking at the test of another student, allowing another student to view your exam, or obtaining information about a test in advance are all examples of cheating. A number of safeguards will be employed to discourage cheating. For example, examination supervisors (proctors) of the tests may ask students to move to another seat during the exam, cover their paper, avert their eyes from other students' papers, remove baseball caps, etc. This is not meant as a personal affront nor as an accusation of cheating, rather as vigilant attempts at proctoring.

The penalties for a student guilty of a scholastic offense may include a zero grade on the assessment, refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

# 15. Procedures For Appealing Academic Evaluations

- 1. In the first instance, all appeals of a grade must be made to the course instructor (informal consultation).
- 2. - 3. If the response of the Undergraduate Chair is considered unsatisfactory to the student, they may then appeal to the Associate Dean, Undergraduate of the Faculty in which the course of program was taken
- 4. Only after receiving a final decision from the Dean may a student appeal to the Senate Review Board Academic. A Guide to Appeals is available from the <u>Office of the Ombudsperson</u>.
